### **Curriculum and Credit Framework for Undergraduate Programmes in NEP 2020**

The Himachal Pradesh University approved to adopt the UGC Guidelines on Curriculum and Credit Framework under NEP 2020 for its implementation vide notification no. **7-1/2024-HPU(Acad) dated 02 April 2024**. This **Curriculum and Credit Framework for Undergraduate Programmes** has been designed to bring about systemic reforms in higher education in line with the **National Education Policy 2020 (NEP 2020)**. Govt. College Jukhala, being an affiliated Government College of Himachal Pradesh University, Shimla, shall implement this framework from the academic session **2026-27** onwards.

The framework aims to provide **Flexibility, Multidisciplinary Education, Skill development, Research orientation, Indian Knowledge System** and **multiple Entry/Exit options** so that students can choose their learning trajectories according to their interests, talents and career goals.

**The following objectives of NEP 2020 are kept in perspective while framing Curriculum and Credit Framework for Undergraduate Programmes by HPU:**

- To promote the holistic development of students having the world view of a truly global citizen;
- To provide flexibility to students so that learners can choose their learning trajectories and programmes, and thereby choose their paths in life according to their talents and interests;
- To eliminate harmful hierarchies among disciplines/fields of study and silos between different areas of learning; multidisciplinary and holistic education to ensure the unity and integrity of all knowledge;
- To promote creativity and critical thinking and to encourage logical decision-making and innovation;
- To promote Ethical & Constitutional values;
- To promote multilingualism and the power of language in learning and teaching;
- To impart life skills such as communication, cooperation, teamwork, and resilience;
- To promote research as a co-requisite for outstanding education and development;
- To incorporate Indian Knowledge System relevant for a particular discipline or field of study;

- To emphasize skill development, community engagement, and real-life application of knowledge.

### Qualification Type and Credit Requirements

Qualifications are formal awards (Certificate, Diploma or Degree) conferred by Himachal Pradesh University in recognition of the successful completion of a well-defined programme of study and the attainment of prescribed learning outcomes. A student must earn the minimum credits specified below to be eligible for the award of the respective qualification.

## Significant Notes

1. The prescribed credit weightage includes Lecture, Tutorial, and Practical components.
2. In the first semester, students will be offered three different subjects within the same stream: A, B, and C (Core and Minor are provided here for illustrative purposes only).
3. At the end of the second semester, each student may choose one of two programmes: the Multi-Disciplinary/Interdisciplinary or Single Core Discipline (Major) programme. The student choosing the latter will be required to give his/her Major and Minor at the end of the second semester. Such choices, including DSCs made at the end of the second semester, shall remain in effect until the VI semester.
4. **Additional Seats:** The Colleges may create 10% extra seats over and above the sanctioned strength to accommodate the request for a change of major. Any unfilled or vacant seats may be filled with those seeking a change of Major. Preference will be given to those with the highest CGPA and no arrears in the first year/semester.
5. The DSCs of another discipline for the first two semesters of students who opt for Major programmes will be treated as Minors.
6. A DSC offered in one discipline will be treated as a Minor by another. Students can choose Minor Courses from two different subjects, but must earn a minimum of 12 credits in each.
7. MDCs must be selected from a broad discipline/pool of MDCs other than Major and Minor subjects.
8. AEC/VAC/SEC-3 should be chosen from a pool of courses. Every discipline shall provide these courses, some of which will be offered discipline-specific, while the rest can be open to students of all other disciplines. However, the two SECs (SEC-1 & SEC-2) must be chosen from the discipline-specific (Core and Minor).
9. A maximum of two language courses can be opted for as Core and Minor. ABCs should be in a language other than what is studied in DSCs/Minors.
10. I/A/P/C will be determined at the end of the first semester to enable students to carry out some I/A/P/C activities during winter vacation.
11. To pursue an Honours & Honours with research in the 4th year, students will have to successfully complete 3-year UG Degree and choose only one discipline in both semesters, in which s/he have studied 6 DSCs and 5 DSEs in the first three years.
12. A student who secures 75% or more marks in aggregate till semester 6 (up to a 3-year degree) shall be eligible for a 4-year degree Honours with Research, provided HPU has approved the college to offer it.
13. One course per semester (DSC/Minor/MDC/SEC/etc.) from a subject offered in two (or more) different programs (e.g. BCA and BSc / BPA and BA / BFA and BA / Shastri and BA / etc.) must be the same.
14. Students in the BA programmes can opt for only one DSC each from the Bachelor of Performing Arts (Dance, Music, Vocal & Instrument/Tabla/etc.) and the Bachelor of Fine Arts (Painting/Applied Arts/Sculpture/etc.).
15. Major and Minor shall be awarded on fulfilment of the following conditions: For Major: 60 credits in a 3-year & 80 credits in a 4-year UG programme in a single Major Discipline. For Minor: 32 credits in a 4-year UG programme in a single Minor Discipline.
16. The Dissertation and Project will start in the VII semester. However, the evaluation and assessment will be conducted in both the VII and VIII semesters.

\*As this scheme is being introduced for the first time, it is subject to modifications. Any changes applied in subsequent years after admission to the 1<sup>st</sup> year, will be retrospectively applicable

## Structure of Under-Graduate Curriculum Framework

The UGCF is a structure for **four-year undergraduate programme** in different disciplines with multiple exit options. It offers two broad pathways after Semester II:

- **Multidisciplinary / Interdisciplinary Programme**
- **Single Core Discipline (Major with Minor) Programme**

### Major Course Categories:

- Discipline Specific Core (DSC) – 4 credits
- Discipline Specific Elective (DSE) – 4 credits
- Minor Course (MC) – 4 credits
- Multidisciplinary Course (MDC) – 3 credits
- Skill Enhancement Course (SEC) – 3 credits
- Ability Enhancement Course (AEC) – 2 credits
- Value Added Course (VAC) – 2 credits
- Internship / Apprenticeship / Project / Community Outreach (IAPC) – 4 credits

## 7. Semester and Credit Structure

An academic year/session is divided into two semesters, each semester is of 6 months duration. In a Semester, a student will study DSC, DSE, MC, MDC, SEC, AEC, VAC & do I/A/P/C as well as dissertation/academic project in four-year programme.

During the vacation period, students are motivated for internships, apprenticeships, community outreach etc. This is particularly beneficial for students who plan to exit after two or four semesters of study.

### **i)Major Course/ DSC/Core:**

This is the main subject a student wishes to study during their undergraduate course. It is the area of study that the student is most passionate about and may wish to pursue as a career. Students may be permitted to change their major within the broad discipline at the end of the second semester, providing them with ample time to explore interdisciplinary courses during their first year.

### **ii)Minor Course:**

This is a secondary area of study that complements the student's chosen Major. Students who complete a sufficient number of courses in a discipline or an interdisciplinary area of study other than their chosen Major will qualify for a Minor e.g. 32 credits in case of four-year UG programme in a single Minor discipline. A student may declare their choice of Minor and vocational stream at the end of the second semester.

### **iii)Multidisciplinary Course:**

All undergraduate students are required to complete three introductory-level courses relating to any of the broad disciplines. These courses aim to broaden the student's intellectual experience and form part of liberal arts and science education. Students are not allowed to choose or repeat courses already taken as their proposed Major and Minor stream under this category.

**MDC must be selected from broad discipline/ pool of MDCs other than Major and Minor subjects.**

### **iv)Ability Enhancement Course (AEC):**

The courses aim to enable students to acquire and demonstrate core linguistic skills, including critical reading and expository and academic writing skills. Students will choose from Ability enhancement

Courses-English, Sanskrit or Hindi. **A maximum two languages courses can be opted for as Core and Minor, but then AECs should be in a language other than what is studied in DSCs/Minors.**

**v) Skill Enhancement Courses (SEC):**

These courses aim to impart practical skills, hands-on training, soft skills, etc., to enhance the employability of students. SEC Courses will be of 3-credits each and will be taught upto 3rd semester. Two SECs (SEC-1 & SEC-2) must be chosen from Discipline Specific Course (Core & Minor).

**vi) Value Added Course (VAC):**

These courses are designed to provide extra skills or knowledge beyond the standard curriculum, often tailored towards enhancing employability, promoting entrepreneurship, or developing personal and professional skills.

### Multiple Entry & Exit

The rules and regulations for multiple entry and exit are as per the guidelines for multiple entry and exit in academic programme offered in HPU. Multiple entry and exit option under three-year degree programme with UG Certificate/UG Diploma/or Degree depending upon the number of credits secured:

#### Re-Entry:

1. The student can seek re-entry to the degree programme after exit; however, re-entry should be within a maximum gap period of 3 years after taking exit. Moreover, a student cannot stay out of degree programme for more than three years in aggregate.
2. In addition, the three-year & four-year degree programme have to be completed within the maximum stipulated period of Six and Seven years respectively. In case the gap between the exit and re-entry into UG programme should not be more than 3 years subject to completion of whole UG three/four-year programme within six/seven years respectively
3. Re-entry may be within University i.e. within colleges (shifting from one college to another depending upon availability of seats), it may be called transfer of admission (inter-college migration). By taking consent from both the colleges and final approval by HPU as per norms.
4. Re-entry may be from another University to this University or vice-versa, called Inter-University migration and allowed as per University ordinance rules for migration or notification issued by University from time to time.

## **13. ADMISSION PROCEDURE**

### **Eligibility for Admission**

A candidate will be eligible for admission to the Certificate/Diploma/Degree if he/she fulfils the eligibility conditions as prescribed by HPU Shimla, which are subject to change from time to time.

In general:

- The candidate should have passed 10+2 examination conducted by the HP Board of School Education or an examination recognized as equivalent thereto by HP University, Shimla.
- An applicant must not be more than 23 years of age (25 years for girl students) as on 01-07-2026. The upper age limit for SC/ST candidates is 26 years. The Vice Chancellor of HPU Shimla in

- exceptional circumstances to be recorded in writing, may allow a relaxation in age up to a period of six months.
- Each academic year comprises of two semesters. Minimum attendance required to appear in end-semester examination is 75%. A student having less than 75% in aggregate will not be allowed to appear in end-semester examination.
  - A student shall be promoted from 1st Year to 2nd Year upon passing at least 50% of the total credits offered in the 1st year. Similarly, a student shall be promoted from 2nd year to 3rd year upon passing at least 50% of the total credits offered in the first two years taken together. Promotion from 3rd to 4th year shall be allowed when student successfully qualify all the courses of the first three years.
  - If student does not take admission in a semester, he/she will not be promoted to next semester and student will have to take fresh admission again in the same semester in the next academic session.

### **Degree Completion Duration**

- Regular student of affiliated colleges can complete the Degree programme within the stipulated maximum period of 7 years for 4-year degree programme and 6 years for 3-year degree programme. The gap between the semesters should not be more than three years as per academic session, subject to the completion of the whole UG Programme within 7 years.

### **DOCUMENTS REQUIRED FOR ADMISSION**

(For Uploading the documents, following scanned certificates are required during online filling of admission form)

1. Matriculation certificate for Date of Birth.
2. 10+2 marks sheet.
3. Admit Card of qualifying/ previous class final Annual Examination.
4. Detail Marksheet (DMC) of the previous class passed (as and when result declared).
5. Female students who are residents of Himachal Pradesh are eligible for an exemption in tuition fees. to avail this benefit, she must provide a valid HP domicile certificate
6. Minimum 40% disability certificate and category certificate in case of students seeking admission against these seats.
7. Original character certificate from Head of the Institution last attended. In case of private candidates, the character certificate must have been issued by a Gazetted officer/ Panchayat Pradhan/ Ward Counsellor but not older than 6 months from the day of submission of admission form.
8. For seat against the single girl child category, an Affidavit proclaiming the same from the parents is to be submitted with the admission form.
9. A candidate having a gap of one or more years in his/her studies will have to submit an affidavit issued by court only, explaining the reasons thereof.
10. Certificate of SC/ ST from Magistrate Class-1 (Authorised Signatory) should be provided by those seeking relaxation in age/ marks.
11. Any gap (latest) in the academic career of the applicant must be supported by a documentary evidence / affidavit as proof of his/ her activities during the period of gap.

- i. Every student must have his/her own e-mail ID.
- ii. Parents must ensure the entry of their Mobile No. in the admission form in order to make it convenient to send them important messages.

5. The application form is to be filled up by the applicant after reading all the instructions, rules and eligibility conditions. The submission of application form for admission shall imply that the applicant is familiar with admission rules and code of conduct in the college and has agreed to abide by the same.
6. Subject wise merit list will be displayed on the college website and the college notice board on the scheduled dates in case of 1st semester students.
7. The students seeking admission in the middle of their degree programme from different college to Govt. College Jukhala will be allowed, subject to the availability of seats.
8. The admission forms of the candidates appearing in the merit list will be scrutinized online by the concerned Admission Committee.
9. Roster for reservation of seats in various categories shall be as per rules of H.P. University, Shimla.
10. Incomplete admission forms and those without copies of uploaded documents will not be entertained.
11. Every student seeking admission to 2nd (even) semester will be required to pay a sum of ₹350/- per semester towards PTA fund (non-refundable), during the second fee instalment.

However, in case of more than one child of the same parents, PTA fund will be charged from one of the students subject to production of valid documents about their relationship. No admission, whatsoever, shall be made after the due date.

12. All admissions will be as per admission schedule notified by H.P. University from time to time
13. All admissions will be provisional subject to the approval of Vice Chancellor, HPU Shimla-5.
14. All the fee and funds are to be deposited within the stipulated time period.

**Note: If a candidate does not deposit fees within the stipulated time period, his/her admission will be deemed cancelled.**

**Important:** The students, who are required to produce affidavits for admission, must consult the admission committee about the contents/statement to be given in the affidavit so that any inconvenience at later stage may be avoided. Submission of false affidavit is a legal offence.

### Counselling

1. Online admission will not guarantee admission to the College, unless the candidate produces all original certificates and documents (uploaded while applying for admission) at the time of physical verification during the counselling.
2. Counselling in physical mode will be conducted for 2nd and 3rd year students from 12th June 2026 to 19th June 2026
3. Students must be accompanied by a parent/guardian to the counselling.

### Migration

Migration from any other College to Govt. College, Jukhala or vice-versa is governed by H.P. University rules. Fees and funds will be charged from student as per Govt and University rules. **PTA Fee is not refundable in any case**

### REFUSAL OF ADMISSION

1. A candidate expelled by any college/university or found involved in any act of indiscipline in the preceding year(s) will not be admitted to the college.
2. The students having compartment in 10+2 class are not eligible for admission.
3. Any candidate who has not appeared/passed in English as a subject at 10+2 level shall not be eligible for admission to B.A. I year.
4. If a student gets admission by furnishing incorrect information or by concealing facts, his /her admission will be cancelled on detection of such fault by the college/ university.
5. The Principal reserves the right to reject or cancel the admission of any student, or to expel/ suspend him/her, without assigning any reason(s) or explanations, if situation so warrants.

## **16. GENERAL CONDUCT AND DISCIPLINE RULES**

All the students must note that Ragging inside/outside the college campus or on roads leading to college is a cognizable offence. In addition, any of the following activities will be considered as breach of discipline:

- a) Graffiti, i.e. any sort of writing/painting on the walls/ blackboards/ rooms, etc.
- b) Damaging/defacing the college property in any manner.
- c) Loitering about the corridors and causing disturbance to the classes.
- d) Possession or use of drugs and indulgence in smoking or drinking in and around the campus.
- e) Bringing outsiders to the college.
- f) Pasting any kind of bills/notice on the notice board without the prior permission of the Principal.
- g) Creating any kind of violence or nuisance in the campus.
- h) Coming to the college without I-Card.

- i) Use of the mobile phones in and around the classroom(s) and Examination-Hall(s).

**Use of the mobile phones by the students in and around the classroom(s) and Examination-Hall(s) is strictly prohibited.**

#### **Caution**

- i) Strict action will be taken against the student found guilty of breaching conduct or discipline rules in the college campus.
- ii) Defaulters including students whose names have been struck off the roll(s) will not be allowed to enter the college premises until exonerated or readmitted appropriately.

### **17. ATTENDANCE**

1. At least 75% Lecture attendance is compulsory to be eligible for appearing in the End Semester Exams of HPU.
2. The name of an irregular student, or one who remains absent continuously for 10 days from college/any elective subject, will be struck-off from the college rolls. If the name of a student is struck-off twice, he/she shall not be readmitted to the college. It may be noted that re-admission to college is not the right of any student/candidate after struck-off due to serious breach of discipline.
3. A student is liable to pay all dues and fines as long as his/her name remains on the college rolls.

### **18. LEAVE RULES FOR STUDENTS**

1. It is compulsory for all the students to get their leave sanctioned from the concerned Faculty, before proceeding on any kind of leave.
2. For leave on medical grounds extending more than a week, the student will be required to submit a medical certificate.
3. Leave up to one week will be sanctioned by the concerned Faculty. For leave extending more than one week's duration, the student shall have to apply to the Principal.
4. A student will not be allowed to avail more than 10 days leave during the entire academic session, except under exceptional circumstances.
5. If a student is regularly skipping classes or does not submit assignments, his/her name will be struck off from the rolls of the College.
6. Even if a student is on leave, he/she will have to deposit his/her fee as per the scheduled dates decided by the College.
7. The students can seek re-admission twice during the session. First re-admission will be allowed within three days after the name is struck off after paying a fine of Rs. 100/- and a fine of Rs. 200/- will be charged for the second re-admission within 10 days after the name is struck off from the rolls.

### **19. LIBRARY RULES**

The following shall be entitled to use the college library and borrow books for home reading:

1. Library will be open from 10A.M. to 5 P.M. on all working days.
2. Students shall be permitted to keep books for a period of two weeks.

3. A fine of Rs. 1/- per day per book will be charged from the student for keeping books beyond the period of two weeks.
4. The faculty members can borrow four books at a time.
5. Library books will be issued to a student only on the production of duly signed student's Identity-cum-Library Card.
6. A student will be responsible for all the books issued to him or her on the card even if the card is lost.
7. Marking, underlining or writing on library books is strictly forbidden and punishable.
8. The loss of the Identity-cum-Library Card should be immediately reported to the librarian. A duplicate Card will be issued after depositing the prescribed fee.
9. Any borrower, who loses, defaces or in any way damages a library book, shall be liable to pay the current price of the book.
10. A 'No Dues Certificate' by each student is to be obtained from the librarian while withdrawing his/her candidature from the college.
11. A perfect order and silence shall be maintained in the library at all times.

## **20. IDENTITY CARD**

Every Student will be issued an identity Card. Since I-Card is the only medium to identity/differentiate a bonafide college student from an outsider, every student must always carry it with him/her. Otherwise, he/she will be considered an outsider action will be taken accordingly.

- If the I-Card is lost, a duplicate card will be issued only after an FIR is registered with the nearest police station and original copy thereof is appended with such a request.

- The actual amount will be charged for issuance of a duplicate Identity Card.

***Note: A duplicate identity card will be issued only after proof of FIR registered with the nearest police station is attached with the application.***

## **22. FINES & PENALTIES**

1. If a student does not pay her/his dues by the notified dates, her/ his name will be struck off the College rolls at the end of the month.
2. A student's name will be struck off if she/he is absent without sanctioned leave for 10 or more consecutive days.
3. If a student's name is struck off, she /he must be accompanied by a parent or guardian for readmission.
4. Students must seek readmission within seven days after her/his name is struck off.
5. Students must obtain a no-dues certificate from the College, Library, concerned Department, N.S.S., Sports, College Canteen, and Fee Clerk if they wish to leave the college.
6. Library security will be forfeited if a student does not apply for a refund within one year of leaving the college.
7. Duty Leave must be entered with respective subject teacher, in case of student's proceeding for the participation in various co-curricular activities (sports/academics/cultural).

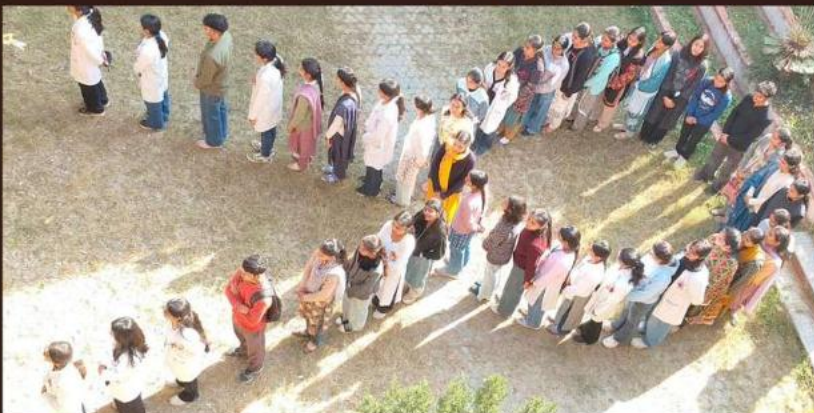
